XIX Indoor Football Tournament

for the GAZ-SYSTEM SA President's Cup

Toruń, October 25-28, 2024

I.General rules

- 1. The organiser of the 19th Indoor Football Tournament for the GAZ-SYSTEM SA President's Cup is the Sports and Tourism Association "Sportgas"
 - 2. The tournament will be held in accordance with all sanitary rules and requirements in the organisation of such events, should the need arise.
- 3. Competitors are obliged to comply with applicable regulations, these Regulations and guidelines regarding sanitary requirements.
- 4. The Organizer announces that due to sanitary restrictions, the rules for organizing the Tournament described in these Regulations may be modified to the extent necessary to comply with the requirements of the law, including the possibility of changing the deadline.
 - 5. The Tournament Office on 26-27 October 2024 will be located in the Filmar Hotel and in the Sports Hall Sportowa "Spożywczak" at ul. Grunwaldzka 33/35 in Toruń.
 - For safety reasons, it is forbidden to consume alcohol or other intoxicants before and during the Tournament. The Organizer reserves the right to disqualify teams not applying to this provision.
 - During the Tournament, participants will be insured against accidents in the basic variant, covering damage caused to third parties.
 - 8. The administrator of personal data collected from participants will be the Sports and Tourism Association "Sportgas" ul. Kasprzaka 25, 01-224 Warsaw. The processing of personal data will take place on the principles set out in Regulation (EU) 2016/679 of the European Parliament and of the

Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

- 9. Personal data of participants and winners will be processed:
- a) to organize and conduct the Tournament,
- b) for tax purposes (applies to winners) if there are tax obligations.
- 10. Providing personal data is voluntary, but necessary to participate in the Tournament. The Organizer declares that the data of the Tournament participants will not be processed in an automated manner and will not be subject to profiling. Other issues related to the processing of personal data are included in the Application Form.
- 11. These Regulations are effective from the moment of their publication on the website http://www.sportgas.pl/pilka and on the notice board in the Tournament Office. The Organizer reserves the right to make any changes to these Regulations at any time and without prior separate notice; such changes will be immediately published on the notice board in the Tournament Office. The Organizer has the exclusive and final right to interpret the provisions of these Regulations.
- 12. The Chief Tournament Judge will be appointed by the Organizer.
- 13. Competitors declare that they have read the statements contained in the Application Form, agree with them and express their consent, including to filming, photographing, recording their image on video tape for the purposes of publication, promotion and advertising of Sportgas and Partners, including by posting reports from the Tournament, in all kinds of industry bulletins, on websites, social networking sites, etc.
- 14. Current information about the Tournament and its progress will be published on <u>www.sportgas.pl</u> and on FB and Instagram social media profiles.

II. CONDITIONS OF PARTICIPATION

- 15. The tournament is amateur, recreational and integration in nature.
- 16. The Tournament is open to employees of oil, gas, energy and heating companies, including subcontractors operating for the industry from Poland and abroad, as well as guests invited by the Organizer.

- 17. Players who actively play football, play or are registered for competitions in the Ekstraklasa, I, II or III leagues cannot be participants in the Tournament.
 - 18. The Tournament involves teams of 7 people (maximum 10 people) representing individual companies. It is possible to register a larger number of participants after prior arrangement with the Organizer.
 - 19. Final, detailed arrangements regarding the course of the Tournament will be provided at the technical briefing on the day preceding the competition.

III. ORGANIZATION OF COMPETITIONS

- 20. For a win a team receives 3 points, for a draw 1 point, for a loss (including walkover) 0 points, win by walkover 3 points.
- 21. 1. The place in the table is decided by: 1 first (so-called step 1):
 - a) number of points obtained in all group matches (primary criterion and default),
 - b) better goal difference achieved in all group matches

c) number of goals scored in all group matches,

21.2. If two or more teams in the same group are equal in all three of the above criteria, their places will be determined according to the following criteria (so-called step 2):

- A) the number of points obtained in the group matches between interested teams (so-called head-to-head record)
- B) a better goal difference resulting from the group matches between interested teams
- C) the number of goals scored in all group matches between interested teams
- D) a draw conducted by the tournament judges
 The teams that take first place in the group advance.

21.3 The stakes of the eight best teams (applies when there are more than 4 groups and less than 8) complete the best teams among those who took second place in groups. Then we create a so-called small table, containing the teams in second place.

21.4 The order in the table of "vice leaders" of the groups is determined first (so-called step1), according to criteria and the following factors:

(a) the number of points obtained in all group matches (primary criterion and default)

(b) better goal difference achieved in all group matches

(c) the number of goals scored in all group matches

21.5 If two or more teams in the same group are equal in all three of the above criteria, their places will be determined according to the following criteria (so-called step 2):

(a) the number of points obtained in the group matches between interested teams (so-called headto-head record)

(b) a better goal difference resulting from the group matches between interested teams

- (c) the number of goals scored in all group matches between interested teams
- (d) a draw conducted by the tournament judges.
- 22. The final round matches must produce a winner. In the event of a tie in regular time, the winners will be determined by a series of penalty kicks (first 3, and if these do not bring a decision -series "until the end").
- 23. If both teams do not show up for the match on the scheduled date, the result will be verified as a mutual defeat without goal consequences.
- 24. The time stated in the schedule is the match start time.
- 25. A match can only start if there are at least 4 players in each team. If the team is represented by a smaller number of players and is considered a team incomplete and the match result will be verified against her with a ratio of 3:0 and 0 points.

IV.FINAL PROVISIONS

26. In the event of non-compliance with the rules or regulations of the game or vulgar behavior, the Organizer has the right to:

a) verification of the match result,

- b) disqualification of a competitor or team from the competition.
- 27. Persons taking part in the games should undergo medical examinations confirming their good health beforehand. The players are responsible for failure to perform the examinations and the resulting accidents and legal consequences.

- 28. The Organizer does not bear any legal responsibility for accidents resulting from the participation of sick persons in the Tournament and for accidents resulting from this and the effects of accidents before, after and during the game.
- 29. The organizer reserves the right to change the date of matches during the competition.
- 30. Sportgas is not responsible for items left on the premises of the facility where the Tournament takes place.
- 31. Any disputes will be resolved by the competition verification committee consisting of: the main judge, the coordinator from the Organizer and the competition manager. The decision of the verification committee is final and irrevocable.

V.RULES OF FUTSAL

- 32. The tournament takes place in a sports hall on a surface the size of a handball court.
- 33. Teams will play in five-player squads (goalkeeper + 4 field players), and the game can start with a team consisting of four players.
- 34. If, in the case of sending off, a team has fewer than three players (including the goalkeeper), the game shall be abandoned.
- 35. A change of players does not require a break in play provided the following conditions are met:
- 36. a player leaving the pitch must cross the side line within his team's substitution zone,
- 37. a player entering the pitch must also do so within the substitution zone, but not before the player leaving has completely crossed the side line,
- 38. the change is made when the substitute player enters the pitch, from that moment he becomes a playing player and the player he replaced ceases to be a playing player,
- 39. the goalkeeper can change places with an outfield player, but this happens during a break in the game and always with the referee's consent, but this player (or a substitute) must wear a shirt of a different colour to the players playing in the match.
- 40. Game time: 1 x 20 min., 1 x 15 min. or 2 x 10 min.
- 41. Players must wear uniform sportswear and footwear designed for playing in the arena with a flat (rubber) sole.
- 42. A competitor may not wear anything that may endanger the safety of other competitors.

- 43. A direct free kick is awarded to the opposing team if a player commits one of the following offences:
 - a) kicks or attempts to kick an opponent,
 - b) trips or attempts to trip an opponent,
 - c) jumps at the opponent,
 - d) attacks /even with the shoulder/ the opponent,
 - e) hits or attempts to hit an opponent,
 - f) pushes the opponent,
 - g) holds the opponent,
 - h) spits at an opponent,
 - i) deliberately touches the ball with his hands (except the goalkeeper in his own penalty area);
- 44. An indirect free kick is awarded to the opposing team if a player commits one of the following offences:
 - a) playing in a dangerous manner (overlay),
 - b) deliberately obstructs the opponent's movement (without intending to play the ball),
 - c) prevents the goalkeeper from releasing the ball from his hands,
 - d) a goalkeeper (in his own penalty area) touches or plays the ball with his hands after it has been deliberately kicked to him by a team-mate,
 - e) the goalkeeper (in his own penalty area) touches or plays the ball with his hands after receiving it directly from a throw-in performed by a teammate
- 45. A player must be cautioned with a yellow card if he commits one of the following offences:
 - a) is guilty of unsportsmanlike conduct,
 - b) demonstrates his/her dissatisfaction verbally or actively,
 - c) persistently violates the rules of the game,
 - d) enters or returns to the pitch without the referee's consent,
 - e) deliberately leaves the field of play without the referee's consent,
 - f) attacks an opponent recklessly,,
- 46. A player must be sent off and shown a red card if he commits any of the following offences:a) he plays brutally,

b) spits at an opponent or another person,

c) is behaving in a very unsportsmanlike manner,

d) uses vulgar, insulting, or derogatory language,

e) denies the opposing team a goal or an obvious opportunity to score a goal by handling the ball (this does not apply to a goalkeeper in his own penalty area),

f) denies an obvious goalscoring opportunity to an opponent moving towards that player's goal by committing a penalty offence with a free kick or a penalty kick.

- 47. The penalty kick is taken from a distance of 6 meters.
- 48. A goal kick is an indirect free kick taken by the goalkeeper (with hands only). The goalkeeper may throw the ball across the halfway line into the opponent's half. A goal cannot be scored directly from a goal kick or a throw-in.
- 49. A throw-in is awarded to the opposing team to the player who last touched the ball, from the point where the ball has wholly crossed the side line, on the ground or in the air, or hit the ceiling (play is restarted with the ball standing on the touchline).
- 50. If the team taking the free kick delays taking it for more than 5 seconds, the referee will award an indirect free kick to the opposing team.
- 51. The goalkeeper has 5 seconds to restart play with the ball in his hands.
- 52. Any number of passes to your own goalkeeper are allowed (the goalkeeper cannot catch the ball passed by one of his own players).
- 53. The defending team's "wall" is set 5 m from the ball.
- 54. A goal scored on the same day as the siren counts
- 55. Penalties:

-żółta kartka;

-red card - 2 min., the player who received it cannot enter the match until the end and in the next match (after two minutes or after conceding a goal, another player enters).
